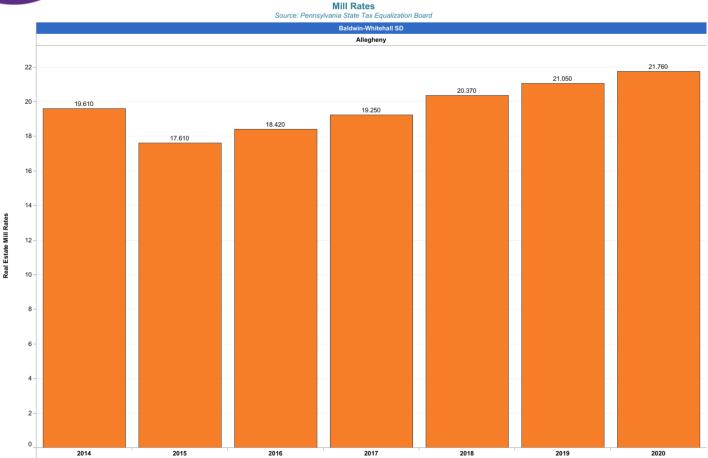

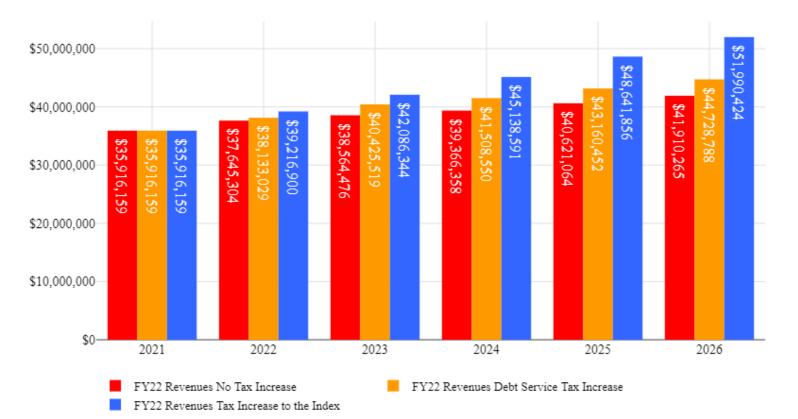

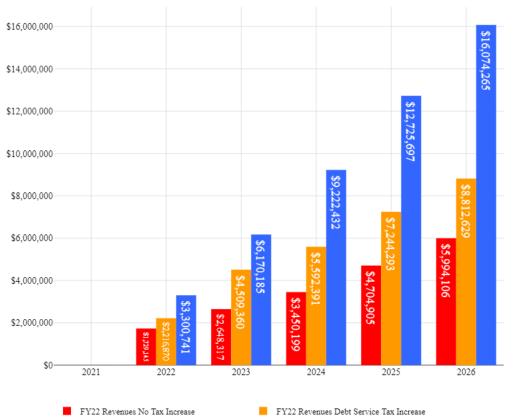


**Projected Property Taxes**

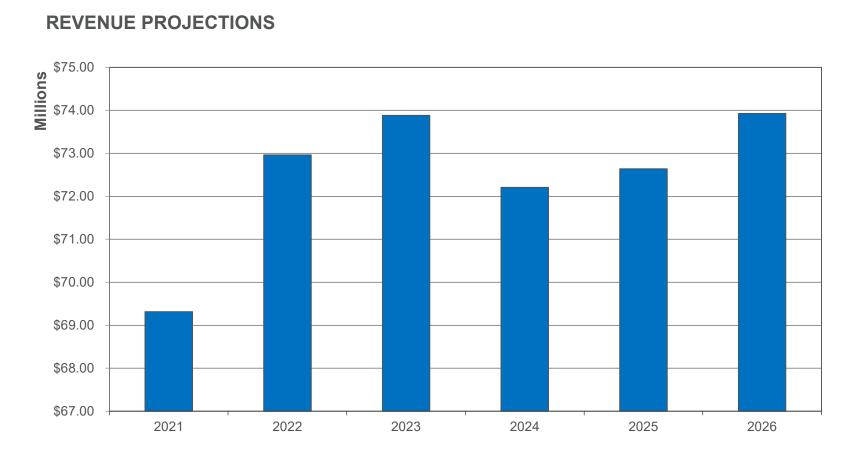
