IMPORTANT MEAL BENEFIT INFORMATION

Households are giving a *grace period* of 30 operating days at the beginning of the new school year to complete their new meal benefit application. **The deadline for meal applications to be submitted is October 10.** Effective Tuesday, October 11, all student meal status eligibilities default back to **PAID** eligibility status **UNLESS** a new meal benefit application for the 2016-2017 school year was submitted and approved for Free or Reduced Price benefits. Parents are encouraged to apply online for meal benefits for the 2016-2017 school year now to prevent any interruptions of meal benefits. *If meal eligibility status goes back to PAID status on October 11th, parents will be responsible for paying the full price for breakfast and lunch meals served.*



REMEMBER: Deadline is October 10, 2016

<u>TAKE ACTION NOW...</u> Parents can go to the website https://www.paschoolmeals.com/Register.aspx to complete a meal application for the current school year. You can access this website from the district website under the Parent tab > click on Free or Reduced Lunch Applications.

Meal status eligibility from the previous school year is *only* good until October 10, 2016. Households must reapply for meal benefits every school year *after July* 1. Please take action now to prevent losing your meal benefits.

If you received a **Direct Certification Letter** from the Baldwin-Whitehall School District **after July 1, 2016** that lists your children's names in the household as eligible for Free meals for the 2016-2017 school year, you do <u>not</u> need to complete a meal benefit application this school year. Each child's name in your household must be listed in that letter.
