FRINGE BENEFITS OPEN ENROLLMENT 2021-2022

The Allegheny County Schools Health Insurance Consortium (ACSHIC) makes changes to health benefit plans every year. If you would like to make changes to any of your fringe benefits, you may do so during **Open Enrollment beginning May 15, 2021 through June 15, 2021**.

New rate changes are effective July 1, 2021 for all groups. The Benefits you select will be in effect from July 1, 2021 through June 30, 2022; however, the Benefits that active teachers select will be in effect from September 1, 2021 through August 31, 2022.

After July 1, 2021, you can only become eligible for or make changes to your health insurance by a "qualifying event" (i.e., marriage, birth of a child).

The District is continuing this year with the electronic Open Enrollment. These two pages give you the ability to complete mandatory/annual forms and open links to see each Open Enrollment document individually.
