FRINGE BENEFITS OPEN ENROLLMENT 2022-2023

The Allegheny County Schools Health Insurance Consortium (ACSHIC) makes changes to health benefit plans every year. If you would like to make changes to any of your fringe benefits, you may do so during electronic **Open Enrollment beginning May 1, 2022 through May 27, 2022.**

New rate changes are effective July 1, 2022 for all groups. The Benefits you select will be in effect from July 1, 2022 through June 30, 2023; however, the Benefits that active teachers select will be in effect from September 1, 2022 through August 31, 2023.

Open Enrollment is the time that you can make changes to your benefits outside of a qualifying life event. For information on changes that are outside of open enrollment, please see the [HIPAA](#) Notice of Special Enrollment Rights.
